### **Delegating is Hard**



Yes, delegation is one of the hardest things to do, but if you do not delegate you become overwhelmed to the detriment of your health, your family but above all your clients.

What is more, things will at some stage go wrong, and you will have to step in to bring maters back on track. So it is not a one off event but a process which involves some

movement back and forth.

- Processes make delegating easier, and make good practice replicable. Document each process to make them clear and easy to follow. This also makes life easier for new employees.
- Your employees are human, and will be prone to error (the same applies to you). Look out for mistakes, and teach your staff to do better. Encourage people to come to you to disclose errors, this can nip problems in the bud.
- Measure what is important to you on a weekly and monthly basis. Trust but verify.
- Look at client satisfaction, quality, timeliness, efficiency and costs.
- Your employees are a vital element in making delegation work. Involve them in writing processes. They probably understand them better than you, but more importantly they share ownership instead of facing a top down dictat.
- Similarly, engage employees in measuring performance indicators.
- Start delegating non-critical tasks.
- The last on the list of tasks to delegate is writing cheques and using the company credit and debit cards. Keep control until you absolutely have to delegate, and then

set appropriate authority limits and checks and balances. Discuss these with your accountant.

• Delegation is an opportunity to teach and train, improving the abilities of your staff.
